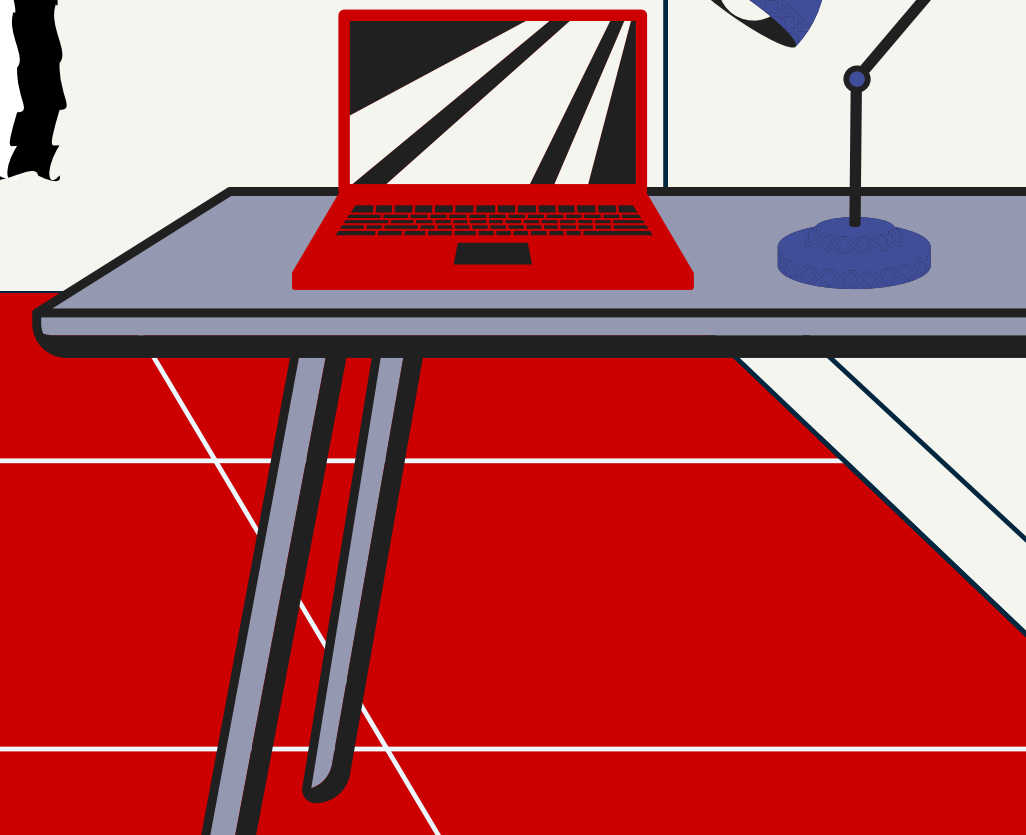
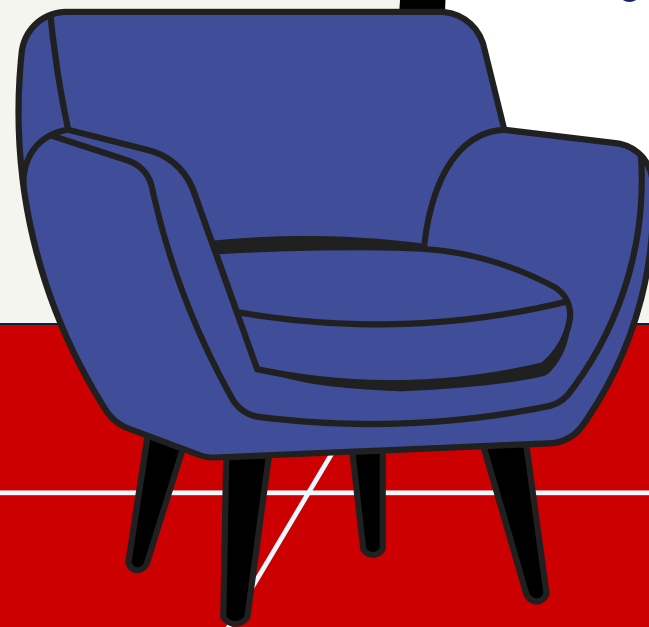


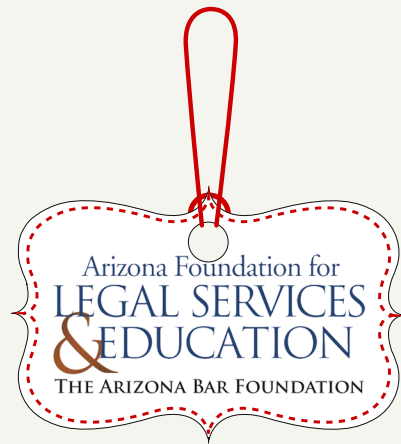


American Civics Education Pilot

Legislative Program - Develop an assessment more rigorous than the Naturalization Graduation Test

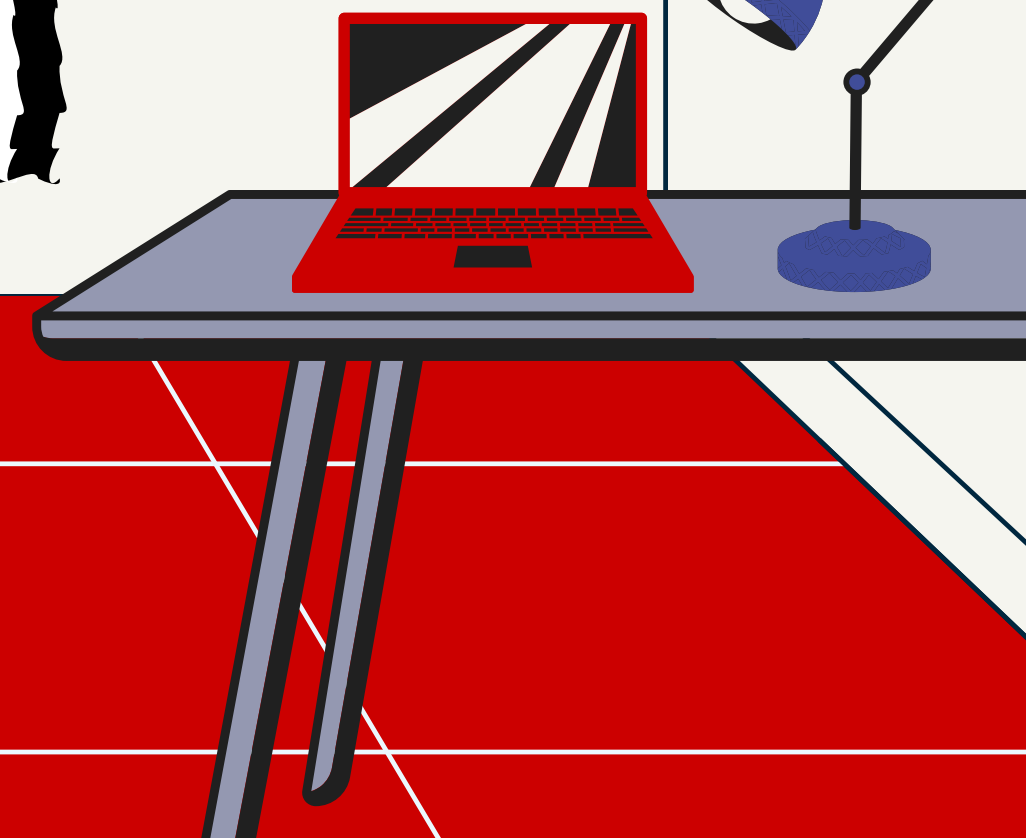
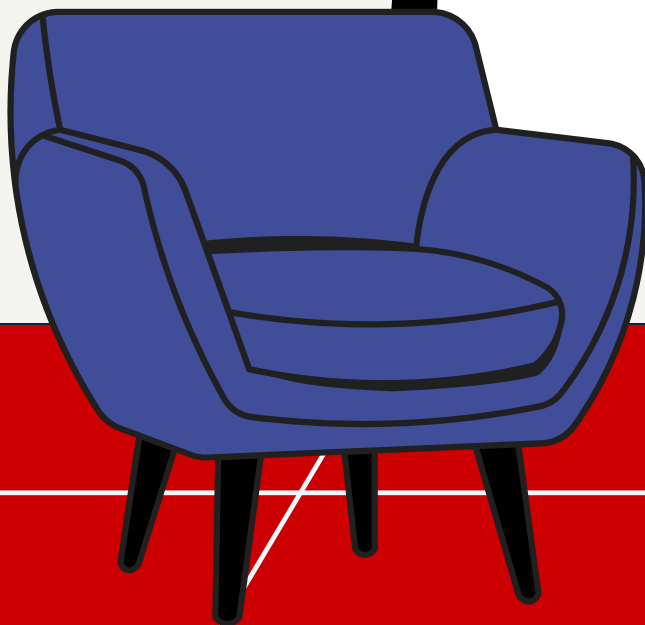
- RFP Process - Foundation proposal awarded

- Administer WTP performance assessment and unit assessments with fidelity.

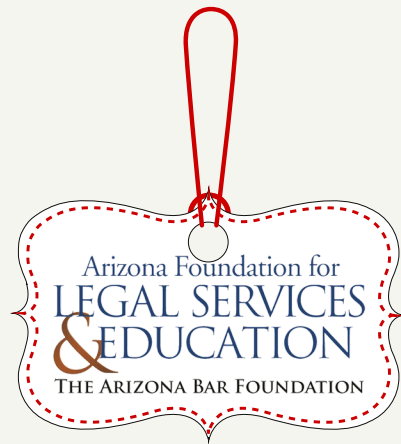

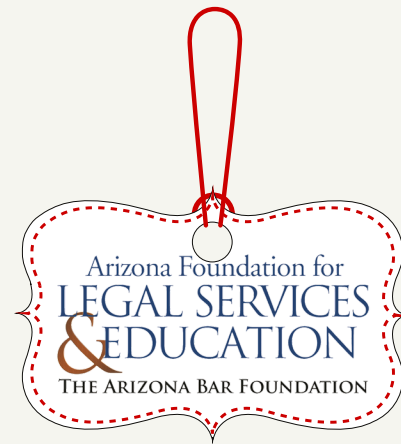




ACEP Implementation

- Have the incredible opportunity to be a part of **History in Arizona!!!**

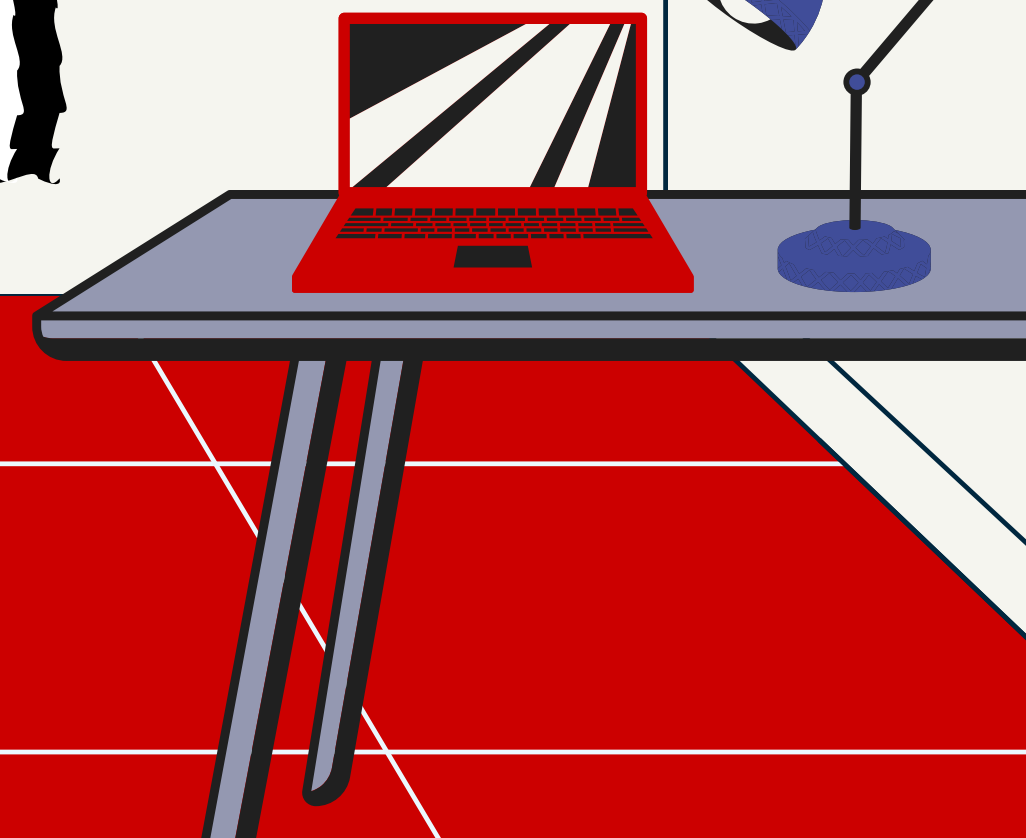
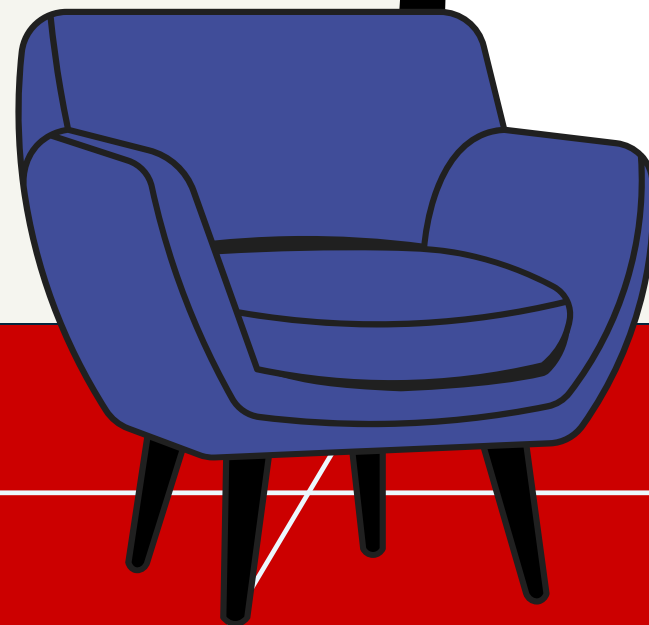


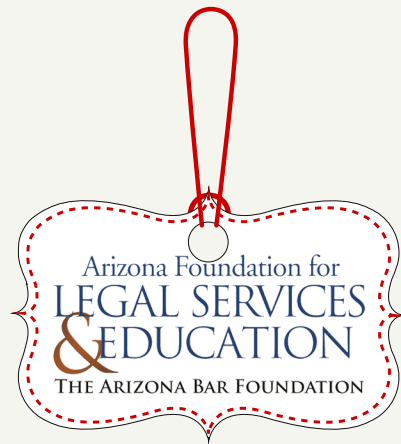
